

# **T&CS - Go The Distance**

## **1. Acceptance of terms**

1.1 By registering for either activity, you agree to these Terms & Conditions and any safety instructions issued before or during the event.

1.2 Registration is not confirmed until payment is received and relevant waivers are completed.

## **2. Waivers and participant responsibility**

2.1 Open-water swim participants must complete Box End Water Park's own waiver as a condition of entry and participation. Fun 4 Young People's documents do not replace or override the venue waiver.

2.2 Colour run participants must complete Fun 4 Young People's Colour Run Waiver & Health Declaration.

2.3 You confirm that all information provided in waivers/health declarations is accurate and complete. You are responsible for judging your own fitness to participate.

## **3. Family tickets (answers given on behalf of others)**

3.1 If you purchase a family ticket covering more than one participant, you confirm that:

- you are authorised to register and provide information on behalf of all participants included in that booking;
- you have explained the key event information, risks, and safety rules to each participant (and/or their parent/guardian);
- any information you provide in the Colour Run Waiver & Health Declaration applies to every participant in the family booking; and
- Fun 4 Young People will rely on your answers for safety purposes.

3.2 You accept responsibility for ensuring all participants in your family booking meet any age, health, and safety requirements.

## 4. Safety and conduct

4.1 You must attend the safety briefing (or read written briefing if provided) and follow all instructions from event staff, lifeguards, marshals, or venue personnel.

4.2 The organiser and/or venue reserves the right to refuse entry, remove anyone from the course/water, or stop participation if:

- A participant appears unfit to take part safely,
- Safety rules are breached,
- Behaviour is dangerous, abusive, or disruptive, or
- A participant is under the influence of alcohol or drugs.

4.3 Participants must treat staff, volunteers, other participants, and the public with respect at all times.

## 5. Inherent risks

5.1 You acknowledge that both activities involve inherent risks.

5.2 For the colour run, these may include slips, trips, falls, collisions, muscle strains, and irritation from coloured powder.

5.3 For the open-water swim, risks include cold-water shock, fatigue, cramps, collisions, and drowning; safety cover reduces risk but does not remove it. These risks are detailed further in the venue waiver.

## 6. Liability

6.1 Nothing in these Terms & Conditions excludes or limits liability for death or personal injury caused by the organiser's negligence, or for any liability that cannot be excluded by law.

6.2 Subject to clause 6.1, the organiser is not responsible for loss, damage, or theft of personal property during the event. Any baggage areas are used at your own risk.

6.3 You agree to take reasonable care for your own safety and that of others.

## 7. Event changes, postponement or cancellation

7.1 The organiser and/or venue may change the schedule, route, swim course, distances, start times, or safety arrangements if required for safety or operational reasons.

7.2 The organiser may postpone or cancel the event due to circumstances beyond reasonable control, including severe weather, unsafe water conditions, venue closure, or public safety advice.

7.3 If the event is cancelled, we will offer either:

- a full refund of your entry fee minus unrecoverable costs, or
- transfer to a rescheduled date, if available.
- The chosen approach will be stated in pre-event communications.

## 8. Entries, refunds and transfers

8.1 Refunds up to 7 days before the event. Attendees will receive the cost of their ticket, minus a ticketing fee.

8.2 If you can no longer attend before the cut-off date, you may request a transfer to another named participant.

## 9. Age limits and supervision

9.1 Colour run: minimum age 4 on event day. Under-18s require parent/guardian consent and on-site adult supervision.

9.2 Open-water swim: minimum age and supervision are governed by Box End Water Park's rules and waiver.

## 10. Photography and media

10.1 We may take photographs/video during the event for promotional, fundraising, and reporting purposes.

10.2 If you do not wish to be photographed, you must notify the event team on the day. We will take reasonable steps to comply.

## 11. Data protection

11.1 We process personal data to administer the event, ensure safety, and contact you with event information.

11.2 If you opt in, we may contact you about fundraising or future events. You can withdraw consent at any time.
